- 2 That in Reply to the Show Cause Notice issued through Letter No.NRC/ NCTE/ (item No.107)Minutes of the 325th (Virtual)Meeting/2020/211232 dated 19 January 2021 received by this office on 28-01-2021.
3. From the perusal of the Show Cause Notice, the primary reason for issuance of the show cause notice is that 'the college has not been issued Revised Recognition order till date even after implementation of NCTE Regulations,2014 due to non-submission of affidavits during 2015" In this regard it is to inform you that the college has submitted three affidavits bearing number U662349,U662350 &U662351 for B.Ed., M.Ed. & ETT (D.El.Ed.) courses respectively vide this office letter number N-7/792 dated 14-2-2015 (copies enclosed as proof).

4. The Second issue of the concern Show cause notice is "Whether institution had submitted compliance with the conditions prescribed under Regulations, 2014 (Enhanced FDRs, Revised Staff Profile, Additional Built-up Area etc). In this regard it is submitted that the institution had submitted the necessary documents by hand (copy of this office letter Number 2499/NCTE dated 09-06-2016 alongwith supporting documents as proof are annexed herewith)
5. Apart from above two issues, the 3rd issue in the show cause notice is "If the Institution does not fall in any of above two categories, the institution is required to inform NRC about its status". In this regard It is to inform you that the institution has already been received REVISED RECOGNITION ORDERS vide your office letter/order number NRC/NCTE/PB-Common Orders/2015/ 117869 and 119870 dated 2 JULY 2015 for B.Ed. & M.Ed. respectively. Proof of said orders are annexed herewith.

Therefore, now in light of the above reply, it is now humbly prayed that the show cause notice be withdrawn/filed at your end. Before parting, the College again assures that the college is/shall fully cooperate and comply with the norms and standards of the academic course and solicit your precious advices/suggestions of wisdom for the upliftment and betterment of the academic atmosphere.
